The Blaze on reported, “*Man claims he is victim after N-word, ‘Trump’ painted on vehicles. Then police arrest him.*”

A Mississippi man claimed he was the victim of racism-fueled graffiti, but he's been arrested because police discovered the man allegedly orchestrated a hoax. In early February, WREG-TV reported that Southaven, Mississippi, police and the FBI were investigating after Turmaine Foster reported his vehicles had been spray-painted with racist slurs. His pickup truck had the N-word painted on it, while a car had the phrase “Leave nigger” and “Trump” painted on it. A neighbor of Foster's told WREG, “That it was a hoax just kind of made us look silly, that's just embarrassing. That's absolutely embarrassing.” As far as a potential motive for the crimes, WREG discovered that Foster owns a body shop that primarily specializes in painting cars. National Director of the Knights Party based in Harrison Arkansas, Thomas Robb said, “*The media suggests that this may be an insurance fraud type of case, but what Foster painted, still makes it a hate crime hoax, and it needs to be treated as such.*” Robb went on to say, “*Hate crime hoaxes are on the rise in America, and if you've noticed, they're all against white people.* When have you seen a white claim, someone painted ‘Cracker’ anywhere as a hate crime hoax?” Robb closed saying, “*In my opinion, anyone caught committing a hate crime hoax should get double the punishment of one actually committing a hate crime.*”

Tennessee Governor, Bill Lee proposed constitutional carry gun legislation that would permit law-abiding residents that are at least 21 years old to carry a handgun without a permit, except in certain restricted areas. Constitutional carry applies to both open carry and concealed carry. Current state law requires a permit for both. Lee said, “The Second Amendment is clear and concise and secured the freedoms of law-abiding citizens to keep and bear arms.” Lee continued, “I am pleased to announce constitutional carry legislation today that will protect the Second Amendment rights of Tennesseans, while also stiffening penalties on criminals who steal or illegally possess firearms.” Lee proposed stricter penalties for people who violate gun laws, such as increasing the penalty for stealing a firearm to a felony and increasing the mandatory minimum sentence for firearm theft from 30 days to 189 days, among other things. The National Director of The Knights Party, based in Harrison Arkansas, Thomas Robb, said, “This legislation needs to be passed in all 50 states, Governor Lee said it right, it definitely is the constitutional right of every law-abiding American citizen to keep and bear arms. And there needs to be stiffer penalties for the criminals who abuse this right.”

A recent article headlined, “The inability to speak English shouldn’t qualify as ‘Disability’ for Social Security,” by **The Daily Signal**, stated the following: The Social Security Insurance system was established as a social safety net program for workers who lose the physical or mental ability to work at a sustainable gainful activity level, but it has become so much more.

A former administrative law judge described it, if a claimant were 45 years or older, limited to sedentary work, and claimed an inability to communicate in English, they were a “slam-dunk for benefits.” That is true even if those applying for benefits reside in an area such as Puerto Rico, where English is not the predominant language.

A new rule set to take effect April 27, 2020, will end that by eliminating the inability to communicate in English as a qualifying factor in Disability Insurance benefit determinations.

The misuse and abuse of the Disability Insurance program by people who can perform work has contributed to excessive costs, impending insolvency, extreme wait times, and the programs general failure to adequately meet the needs of individuals who truly cannot work.

Thomas Robb, National Director of the Knights Party, based in Harrison Arkansas said, “This rule will help America’s economy in several ways, first, it will force these lazy Non-English speaking immigrants into actually being productive in our economy instead of being a burden to our taxpayers, and secondly, it will be a boost to our workforce having these people available for work that doesn’t require English to be productive, such as agriculture.” Robb added, “This makes sense - what other country in the world could a White English speaking American migrate to that it’s government and native people pay you to be there, just because you don’t speak their native language?”

Fox News released the headline, “Jenny Beth Martin: Court ruling against sanctuary cities and states should be followed by tough legislation.”

In brief, the story says, the ruling Wednesday by a federal appeals court allowing the federal government to withhold grant money to so-called “sanctuary” states and localities that refuse to cooperate with federal immigration authorities is an important victory that will help protect the American people from dangerous illegal immigrant criminals.

Martin continues later in the story saying, “These state and local governments don’t deserve taxpayer money

when their sanctuary policies endanger the public and undercut law enforcement.” “Congress should now pass legislation that allows the victims of crimes committed by released illegal immigrants to sue for damages.”

Two Republicans in North Carolina, Sen. Thom Tillis and Rep. Ted Budd, have introduced legislation in Congress to do just that. The bill, titled, Justice for Victims of Sanctuary Cities Act, tackles the problem of sanctuary jurisdictions from a new and different angle. It could finally be the legislation needed to break the policy conflict logjam for the first time in decades.

Thomas Robb, the National Director of the Knights Party, based in Harrison Arkansas said, “It’s about time someone takes a good hard stance against these illegals and the crimes they commit against our law-abiding American citizens.”

Robb added, “Our citizens that fall victim to these illegals, their tax monies are going to these cities and municipalities that are “hiding” these illegals committing the crimes.” “It’s time to stop rewarding bad behavior in America.”
